第一條 國立高雄科技大學（以下簡稱本校）為推展特色運動項目、提倡運動風氣，積極鼓勵學生參與校外運動競賽，爭取佳績為校爭光，特訂定本校運動代表隊組訓管理辦法（以下簡稱本辦法）。

Article 1

These Regulations Governing the Management of University Varsity Teams (hereafter referred to as “these Regulations”) are adopted by National Kaohsiung University of Science and Technology (hereinafter referred to as “the University”). The purpose of these Regulations is to enhance awareness and engagement in sports activities, encourage student participation in extramural sports competitions, and aim for outstanding achievements that bring honor and prestige to the University.

第二條 符合下列條件之一者，得於當年度結束前一個月提出運動代表隊成立申請，檢附歷年競賽成績、年度訓練計畫、指導師資及訓練場地等資料，經運動代表隊遴選審議委員會（以下簡稱遴選審議會）初審通過，簽奉校長核可後於下一學年度起成立運動代表隊。另本校規劃長期發展之特色運動項目，得以專簽經校長核定後成立。

一、具有傑出競技成就（近三年曾獲全國中等以上學校聯合運動會、大專運動會

或全國單項運動協會比賽優勝前三名者)且能持續推展、傳承之運動項目。

二、具有發展潛力且能符合本校特色之運動項目，經校長核定者。

三、本校體能性社團連續二年接受評鑑獲評為甲等者。

遴選審議會採任務編組，置主任委員一人，由校長指派副校長一人擔任之；置副主任委員一人，由體育室主任擔任之；由學務長、教務長擔任委員。開會時，由主任委員擔任主席，主任委員不能出席時，由副主任委員代理之。

主任委員得視實際工作需要，聘請其他委員若干人，以遂行遴選事務。

Article 2

2.1 Those who meet one of the following conditions may apply for the formation of a Varsity Team at least one month before the end of the current academic year. The application documents must include annual competition results, annual training plans, and information about coaching staff and training facilities. Upon passing the initial review by the Varsity Team Selection and Evaluation Committee (hereinafter referred to as “this Committee) and obtaining approval from the President of the University, the Varsity Team will be established in the following academic year. Teams with the aim of long-term athlete development in sports, as proposed by the University, may be established upon special approval by the President:

- (1) The sports in which students have exceptional athletic performance (placed among the top three in the national middle or high schools athletic games, National Intercollegiate Athletic Games, or competitions hosted by Individual Sports Association in the last three years) and have the potential for promotion and development;
- (2) The sports that have potential for development in line with the University’s distinguishing characteristics and have received approval by the President of the University;
- (3) The sports clubs that have been evaluated as an A-Level Club for two consecutive years.

2.2 The Committee is structured based on different tasks. The Chairperson of the Committee shall be one of the Vice Presidents appointed by the

President; the Vice Chairperson shall be the Dean of the Office of Physical Education; the Dean of the Office of Student Affairs and the Dean of the Office of Academic Affairs shall also serve as Committee members. When the Committee holds a meeting, the Chairperson will serve as the convener. In cases where the Chairperson is unable to preside over a meeting, the Vice Chairperson shall act on his/her behalf.

2.3 If required, the Chairperson may hire several other members to carry out the selection work.

第三條 運動代表隊義務如下：

- 一、每學期期初由體育室主任召開運動代表隊會議，各隊教練及隊員應確實出席，並於會後將訓練計畫書及隊員清冊送交體育室建檔存辦。
- 二、以運動績優甄審甄試入學學生應加入校內現有運動代表隊及相關體能性社團。
- 三、比賽結束應於賽後二週內繳交比賽成果報告書及核銷經費。
- 四、協助訓練場地設備之清潔維護。
- 五、支援辦理校內各項運動競賽及活動。

Article 3

The obligation imposed on Varsity Team are as follows:

- 3.1 At the beginning of each semester, the Dean of the Office of Physical Education shall convene a Varsity Team Meeting. All the coaches and team members must attend the meeting. The training plan and team roster shall be forwarded to the Office of Physical Education for record-keeping;
- 3.2 Students admitted to the University due to their outstanding athletic performance shall join the relevant Varsity Team or sports clubs;
- 3.3 The final reports and expense reimbursement shall be submitted within two weeks after a competition's conclusion;
- 3.4 Assisting in the cleaning and maintenance of training facilities and equipment; and

3.5 Helping in sports competitions and activities hosted by the University.

第四條 運動代表隊員甄選方式如下：

- 一、本校各項公開選拔賽、系際球賽、校運會、社團活動及校外競賽表現優異者或由任課老師推薦者，得申請加入運動代表隊，由體育室甄選之。
- 二、參加運動代表隊選拔，除前項規定外，應具備下列條件：
 - (一) 身心健康、品德良好、學業總成績及格且操行成績優良。
 - (二) 具有進取心、榮譽感及團隊精神者。
 - (三) 對該項運動項目有高度興趣者。

Article 4

The selection of members in the Varsity Team is as follows:

- 4.1 Students who have exceptional athletic performance in various open events, inter-departmental tournaments, University Sports Day, club activities, and off-campus competitions, or who receive recommendations from instructors may apply to join the Varsity Teams. The application shall be selected and reviewed by the Office of Physical Education.
- 4.2 Those who apply for participation in the Varsity Team member selection shall meet the requirements specified in the preceding paragraph and the following conditions:
 - (1) Possessing good physical and mental health, high integrity, passing grades in all subjects, and excellent conduct grades;
 - (2) Having an ambition to succeed, a strong sense of integrity, and a team-focused mindset; and
 - (3) Demonstrating a high level of interest in the specific sports.

第五條 運動代表隊教練之聘任及義務：

- 一、各運動代表隊應設教練一名，並得設助理教練至多二名，由體育室遴薦校內具有該項專長之體育老師、教職同仁兼任，若校內無該項專長者得薦聘外校教練指導，經校長核定後聘任之。

- 二、訓練時間以每週二次，每次二小時為原則，每學期以四十八小時為上限撥給教練指導費。教練應根據年度組訓計畫以指導隊員從事訓練、比賽並協助指導隊員校外參賽安全有關事宜。

Article 5

Appointment and obligation of coaches in Varsity Teams are as follows:

- 5.1 Each Varsity Team shall have one coach and may have up to two assistant coaches. The Office of Physical Education shall select faculty members with expertise in specific sports to serve as coaches. If there are no faculty members with the required expertise within the University, external coaches from other institutions may be recommended. Coaching appointments must have the approval of the President of the University.
- 5.2 The standard schedule for training is two sessions per week, with each session lasting two hours. Coaches will be compensated with coaching fees for up to 48 hours per semester. In alignment with the annual training plan, coaches shall provide guidance to team members during training and competitions, as well as arrange matters related to the safety of team members during off-campus competitions.

第六條 運動代表隊之訓練與管理規定如下：

- 一、運動代表隊設置後，應設隊長、副隊長或各級幹部負責隊務及聯繫，並配合教練擬訂訓練計畫(例行組訓、賽前集訓或寒暑訓等)，由教練負責督導執行。
- 二、平時訓練以不影響課業為原則，訓練時間至少每週二次，每次二小時為原則，寒暑假視需要另訂之。
- 三、訓練目標須術德並重，遵守運動道德、發揮優良運動風範以爭取良好成績。隊員訓練時應服從教練之指導並遵守團體紀律。
- 四、隊員在訓練中或比賽中如有違反運動精神或校規者；無正當理由而拒絕參加訓練比賽者，均報請學校議處。
- 五、代表隊隊員於訓練或比賽期間遇有重大違規或被記過處分或當學期所修學科成績達二分之一不及格者，即取消其代表隊資格。
- 六、未依規定履行義務或不服從體育室、指導教練督管之運動代表隊訓練績效不

彰者，得由體育室據實專簽建議停隊。

七、各運動代表隊對外參加全國性比賽時，給予公假及經費補助；其他性質之比賽以專簽核准後給予公假。

Article 6

Training and management regulations for Varsity Teams are as follows:

- 6.1 A captain, vice-captain, or other team leaders shall be appointed to oversee the team affairs once the Varsity Team has been established. They shall collaborate with the coach to develop the training plan, which will include regular training, pre-competition training, winter/summer training, etc. The coach shall be responsible for supervising and implementing the training plan.
- 6.2 Training during the semester shall not interfere with academic studies. The training sessions shall, as a rule, be held at least twice a week, with each session lasting two hours. Additional training during winter and summer vacations shall be scheduled if necessary.
- 6.3 Training objectives shall put emphasis on both skills and virtues. Students shall learn to adhere to sports ethics and demonstrate good sportsmanship to strive for excellent performance. Team members shall follow the coach's guidance and uphold group discipline during training.
- 6.4 Team members who violate sportsmanship or University regulations during training or competition, or refuse to participate in training or competition without valid reasons, shall be reported to the University for discussion and be subject to disciplinary action.
- 6.5 If the Varsity Team members commit major violations during training or competition, receive disciplinary sanctions, or fail more than half of their academic subjects in the current academic semester, their qualification for the Varsity Team shall be revoked.
- 6.6 Students who fail to fulfill their obligations as stipulated or disobey the supervision of the Office of Physical Education and coaches, and as a result demonstrate unsatisfactory performance in training may be

reported for suspension by the Office of Physical Education.

6.7 When Varsity Teams participate in national-level competitions, they shall be granted official leave and financial support. For other types of competitions, official leave shall be granted upon approval through special reporting procedures.

第七條 運動代表隊於報名參加校外競賽申請經費補助時，應檢附最近一年相同性質競賽成績證明，經遴選審議會審議通過後得予經費補助。參賽經費補助原則、申請及核銷程序如下：

一、補助原則：

- (一) 經費補助標準依本校體育室「運動代表隊比賽專款補助原則」辦理，凡具資格並代表本校參加全國大專校院運動會、大專校院球類運動聯賽或大專校院單項錦標賽全額補助每年一次；其它全國性賽事補助報名費及保險費每年一次；其餘賽事僅補助保險費，並應事先報請體育室簽准同意。
- (二) 補助人數以註冊報名參賽人數為限。
- (三) 補助日數以實際參加比賽天數為準。
- (四) 參與校外競賽需辦理保險，保險費以身故及殘障保險金每人新臺幣一百萬元、每次實支實付傷害醫療保險金金額新臺幣三萬元編列。
- (五) 非代表本校參加比賽者、未事先報請體育室核備於運動代表隊名冊者不予補助。
- (六) 非本校運動代表隊之各運動項目績優生及體能性社團學生欲代表本校參加校外競賽者，需事先向體育室提出申請，並備妥最佳運動成績，經遴選審議會審核通過後，擇優報名參賽。補助與獎勵比照運動代表隊，經費以專簽處理。

二、申請程序：

- (一) 於賽前一個月，檢具參賽人員名單、保險名單及競賽規程送交體育室辦理，如需預支參賽經費（限新臺幣一萬元以上）請一併申請。
- (二) 經體育室簽准並辦妥請假手續後方可前往參加比賽。

三、核銷程序：賽後二周內檢附相關單據（報名費、住宿費等）、印領清冊（需親筆簽名）、成果報告等資料辦理核銷作業，並將所借用物品全部歸還（運動服

裝應先洗淨曬乾再歸還)。

Article 7

The Varsity Teams must provide documented results from similar competitions in the most recent year when applying for a subsidy to participate in off-campus competitions. The Varsity Teams shall be provided a subsidy after the application has been reviewed and approved by the Committee. The principles, application, and reimbursement procedures for the competition subsidy are as follows:

7.1 Standards for subsidy:

- (1) The standard of subsidy shall be processed in alignment with the Office of Physical Education's Principles for Appropriating Funds to Facilitate University Varsity Teams' Participation in Competitions. Qualified teams representing the University in the National Intercollegiate Athletic Games, any intercollegiate level ball games, or individual sports tournaments shall receive full subsidies once a year. For other national competitions, subsidies shall cover registration fees and insurance costs once a year. For students participating in competitions other than the aforementioned ones, their insurance costs shall be subsidized, contingent upon prior approval and agreement by the Office of Physical Education.
- (2) Subsidies per participant are limited to the number of registered participants in the competition.
- (3) Subsidies per day are limited to the number of days the participants engage in the competition.
- (4) Students participating in off-campus competitions shall acquire insurance. The insurance premium shall cover the death and disability insurance with a coverage of NT\$1,000,000, and include pay-as-you-go medical reimbursement insurance with a coverage of NT\$30,000.
- (5) Subsidies shall not be provided to individuals who do not represent

the University in the competition or have not been included in the Varsity Team roster with prior approval from the Office of Physical Education.

- (6) Students who are not members of Varsity Teams or sports clubs but wish to represent the University in off-campus competition must submit an application to the Office of Physical Education in advance. The application must include evidence of their top athletic performances. Upon review and approval by the Committee, these students will be eligible for subsidies and comparable to those of Varsity Teams with funding subject to specific approval.

7.2 Application procedures:

- (1) The roster of participating athletes, the roster of athletes to be insured, and competition agendas shall be submitted to the Office of Physical Education at least one month before the competition. Should a student require a cash subsidy in order to register for a competition with a registration fee of over NT\$10,000, they must submit an application for a cash advance alongside the aforementioned documentation.
- (2) Participants may not take part in the competition without obtaining approval from the Office of Physical Education and completing the necessary student leave procedures.

7.3 Reimbursement Procedure: Within two weeks after the competition, pertinent documents (the receipt of registration fee, accommodation expenses, etc.), signed collection lists, reports, and other related materials shall be submitted for the reimbursement process. All the borrowed items shall be returned in full (sports attire should be cleaned and dried before being returned).

第八條 各運動代表隊對外比賽獲優異成績者，由教練按其成績表現報請體育室辦理獎勵輔導。

運動績優獎勵金申請實施原則如下：

一、申請資格：

(一) 經核定代表本校參加全國性運動競賽之表現優異學生及教練(團體賽以參賽總隊數為主，個人賽以參賽總人數為主)，申請規範如下：

1. 參賽總隊數四隊或參賽總人數五人(含)時僅取第一名。
2. 參賽總隊數五隊或參賽總人數六人(含)以上時取前二名。
3. 參賽總隊數六至七隊或參賽總人數八人(含)以上時取前三名。
4. 參賽總隊數八隊或參賽總人數十二人(含)以上時取前五名。

(二) 每人/每隊每年擇優申請一次為限，但同一人參加同一賽事不同比賽項目者不在此限。並以下列各項競技賽會為範圍：

1. 全國大專校院運動會、全國大專校院球類聯賽及錦標賽。
2. 全國各單項運動協會或委員會主辦之全國性大專組比賽。

二、經遴選審議會核定以本校名義報名之運動代表隊，應依運動代表隊比賽專款補助原則補助經費，並依參賽成績給予記功及核發(獎勵金；非經遴選審議會核定但以本校名義自行報名自付參賽經費之團體或個人，依參賽成績給予記功並加倍核發獎勵金。

三、申請應於開學第五週前，檢具申請表(如附表一)、獎狀影本、秩序冊(賽程表)送交體育室辦理。

四、資格符合第一款第二目之1者：

(一) 學生(個人賽)：

1. 第一名：每人大功一支，並核發獎勵金新臺幣一萬元為上限。
2. 第二名：每人小功二支，並核發獎勵金新臺幣八千元為上限。
3. 第三名：每人小功一支，並核發獎勵金新臺幣七千元為上限。
4. 第四名：每人嘉獎二支，並核發獎勵金新臺幣六千元為上限。
5. 第五名：每人嘉獎二支，並核發獎勵金新臺幣五千元為上限。

(二) 學生(團體賽)：

1. 第一名：每人大功一支，每隊每人核發獎勵金新臺幣一萬元為上限。

- 2.第二名：每人小功二支，每隊每人核發獎勵金新臺幣八千元為上限。
- 3.第三名：每人小功一支，每隊每人核發獎勵金新臺幣七千元為上限。
- 4.第四名：每人嘉獎二支，每隊每人核發獎勵金新臺幣六千元為上限。
- 5.第五名：每人嘉獎二支，每隊每人核發獎勵金新臺幣五千元為上限。

(三) 教練：

- 1.第一名：每人核發獎勵金新臺幣一萬元為上限。
- 2.第二名：每人核發獎勵金新臺幣八千元為上限。
- 3.第三名：每人核發獎勵金新臺幣七千元為上限。

五、資格符合第一款第二目之2者：

(一) 學生（個人賽）：

- 1.第一名：每人大功一支，並核發獎勵金新臺幣六千元為上限。
- 2.第二名：每人小功二支，並核發獎勵金新臺幣五千元為上限。
- 3.第三名：每人小功一支，並核發獎勵金新臺幣四千元為上限。
- 4.第四、五名：每人嘉獎二支，並核發獎勵金新臺幣三千元為上限。

(二) 學生（團體賽）：

- 1.第一名：每人大功一支，每隊每人核發獎勵金新臺幣六千元為上限。
- 2.第二名：每人小功二支，每隊每人核發獎勵金新臺幣五千元為上限。
- 3.第三名：每人小功一支，每隊每人核發獎勵金新臺幣四千元為上限。
- 4.第四、五名：每人嘉獎二支，每隊每人核發獎勵金新臺幣三千為上限。

(三) 教練：

- 1.第一名：每人核發獎勵金新臺幣六千元為上限。
- 2.第二名：每人核發獎勵金新臺幣五千元為上限。
- 3.第三名：每人核發獎勵金新臺幣四千元為上限。

六、為利資源有效運用分配，申請人應避免與校內其它獎學金重複請領。

- 七、申請人如提供不實或偽造資料，致使體育室依該資料而作成審議結果，經查證屬實者，除追繳已領之獎勵金，另依校規處置。

Article 8

For Varsity Team members who achieve outstanding results in off-campus competitions, the coaches shall submit a report to the Office of Physical Education for recognition and awards based on their performance.

The principles of applying for awards are as follows:

8.1 Qualification:

- (1) The application criteria for students and coaches who excel in representing the University in nation-level sports competitions (prioritizing team events according to the aggregate number of teams and individual events according to the aggregate number of individuals) are as follows:
 - (a) With a total of four teams or up to five participants in the competition, only the team or individual that takes first-place shall be qualified.
 - (b) With a total of five teams or six participants (including six) in the competition, the teams or individuals finishing in first- and second-place winners shall be qualified.
 - (c) With a total of six to seven teams or eight participants (including eight) in the competition, those finishing from first to third place shall be qualified.
 - (d) With a total of eight teams or twelve participants (including twelve) in the competition, those finishing among the top five shall be qualified.
- (2) Each individual/team shall apply for the award annually, but this limitation does not apply to the same individual participating in different events within the same competition. The following competitive events are included within the subsidy scope:
 - (a) National Intercollegiate Athletic Games, as well as any

national intercollegiate ball games and tournaments.

- (b) All national intercollegiate sports events organized by Individual Sports Association or Committees.

8.2 The Varsity Teams registered on behalf of the University, as approved by the Committee, shall be provided financial support in accordance with Principles for Appropriating Funds to Facilitate University Varsity Teams' Participation in Competitions. Commendations and awards shall be granted based on performance. The award-winning Teams or individual players who register for the competition and cover all the fees on their own but did not receive approval from the Committee shall be awarded a commendation and a subsidy that is twice their cash prize amount.

8.3 The application shall be submitted to the Office of Physical Education no later than the end of the fifth week following the commencement of the semester. The application documents shall include the application form (as shown in Appendix I), a photocopy of the award certificate, and the agenda (competition schedule).

8.4 Those who meet the qualifications listed in Article 8, Subparagraph 1, Item 2-1 shall be awarded as follows.

(1) Student (individual)

- (a) First place: Each student shall be awarded one major merit and a cash prize of up to NT\$10,000.
- (b) Second place: Each student shall be awarded two minor merits and a cash prize of up to NT\$8,000.
- (c) Third place: Each student shall be awarded one minor merit and a cash prize of up to NT\$7,000.
- (d) Fourth place: Each student shall be awarded two commendations and a cash prize of up to NT\$6,000.
- (e) Fifth place: Each student shall be awarded two commendations and a cash prize of up to NT\$5,000.

(2) Student (teams)

- (a) First place: Each student in the team shall be awarded one major merit and a cash prize of up to NT\$10,000.
- (b) Second place: Each student in the team shall be awarded two minor merits and a cash prize of up to NT\$8,000.
- (c) Third place: Each student in the team shall be awarded one minor merit and a cash prize of up to NT\$7,000.
- (d) Fourth place: Each student in the team shall be awarded two commendations and a cash prize of up to NT\$6,000.
- (e) Fifth place: Each student in the team shall be awarded with two commendations and a cash prize of up to NT\$5,000.

(3) Coaches

- (a) First place: Each coach shall be awarded up to NT\$10,000.
- (b) Second place: Each coach shall be awarded up to NT\$8,000.
- (c) Third place: Each coach shall be awarded up to NT\$7,000.

8.5 Those who meet the qualifications listed in Article 8, Subparagraph 1, Item 2-2 shall be awarded as follows.

(1) Student (individual)

- (a) First place: Each student shall be awarded one major merit and a cash prize of up to NT\$6,000.
- (b) Second place: Each student shall be awarded two minor merits and a cash prize of up to NT\$5,000.
- (c) Third place: Each student shall be awarded one minor merit and a cash prize of up to NT\$4,000.
- (d) Fourth and fifth place: Each student shall be awarded two commendations and a cash prize of up to NT\$3,000.

(2) Student (teams)

- (a) First place: Each student in the team shall be awarded one major merit and a cash prize up to NT\$6,000.
- (b) Second place: Each student in the team shall be awarded two minor merits and a cash prize of up to NT\$5,000.
- (c) Third place: Each student in the team shall be awarded one minor merit and a cash prize of up to NT\$4,000.
- (d) Fourth and fifth place: Each student in the team shall be awarded two commendations and a cash prize of up to NT\$3,000.

(3) Coaches

- (a) First place: Each coach shall be awarded up to NT\$6,000.
- (b) Second place: Each coach shall be awarded up to NT\$5,000.
- (c) Third place: Each coach shall be awarded up to NT\$4,000.

8.6 In order to efficiently allocate resources, applicants are advised not to pursue multiple scholarships from the University.

8.7 If the applicant's documents are found and discovered to be false or forged, resulting in incorrect decisions from the Office of Physical Education, any awards received will be revoked, and additional disciplinary measures will be enforced in accordance with the University's regulations.

第九條 本辦法所需經費由年度分配預算或受贈收入項下支應：

一、運動教練、助教鐘點費：由年度專項經常門申請或受贈收入。

二、運動代表隊比賽專款：由年度專項經常門申請或受贈收入。

三、運動績優獎勵金：

(一) 學生：由學務處運動績優學生獎學金項下支付。

(二) 教練：由自籌收入分配預算項下支付。(每年獎勵金總額上限為新臺幣 10 萬元整)

前項經費以當年度分配預算為上限，若有不足，補助及獎勵金額由體育室視情況

予以調整。

Article 9

These Regulations' funding shall be provided by an annual budget or supported by donations.

9.1 Coaches' and assistants' hourly wages shall be funded by a dedicated annual current account or donations.

9.2 Competition Subsidies for Varsity Teams shall be funded by a dedicated annual current account or donations.

9.3 Outstanding Athletic Performance Prize:

(1) For students: the prize will be provided by the Scholarship for Outstanding Student Athletes dedicated by the Office of Student Affairs.

(2) For coaches: the prize will be funded by the self-generated income budget allocation (The annual cash prize can be as much as NT\$100,000).

The funding for the preceding paragraph is limited to the current year's allocated budget. If insufficient, the subsidy and the amount of cash prize will be adjusted as deemed necessary by the Office of Physical Education.

第十條 運動代表隊之評鑑、停訓與解散：

- 一、評鑑時間每學年一次，原則上於每年六月辦理，由遴選審議會議評鑑之，覆議時亦同。
- 二、評鑑項目包含校內活動、校外比賽績效、年度計畫、組織運作、資料建檔、財務管理、場地管理與行政配合等。
- 三、評鑑等級分為甲等（八十分以上），乙等（七十至七十九分），丙等（六十至六十九分），以及丁等（六十分以下，含無故不參加評鑑者）。
- 四、經遴選審議會議評鑑結果為丙等、有重大違規或教練提出停訓申請，代表隊得暫時停止組訓及其經費補助，停訓期限由遴選審議會議審議之，覆議時亦同。
- 五、經遴選審議會議評鑑結果為丁等、有重大違規影響校譽、教練辭職、解聘致二個月以上無教練或教練提出解散申請，代表隊應予以解散。

Article 10

The evaluation, suspension, and dissolution of Varsity Teams.

- 10.1 The evaluation will be conducted once a year during the academic year, generally in June. The Committee will oversee the evaluation and the same procedures apply for reappraisal.
- 10.2 The evaluation criteria encompass on-campus activities, performance in off-campus competitions, annual plans, organizational operations, data archiving, financial management, venue management, and administrative coordination.
- 10.3 The evaluation levels are divided into Level A (80 or above), Level B (70-79), Level C (60-69), and Level D (below 60, including those who do not attend the evaluation without justifiable reasons).
- 10.4 If the evaluation result by the Committee is Level C, or if any serious violations occur or if the coach requests a suspension, the training and funding support will be halted. The suspension duration will be determined by the Committee, and the same procedures will apply to reappraisal.
- 10.5 The dissolution of Varsity Teams shall occur in either of the following situations, including the evaluation result by the Committee is Level D, any major violations affect the reputation of the University, the coach resigns, dismissal leads to the absence of a coach for more than two months, or if the coach requests dissolution.

Article 11

These Regulations shall be passed by the Administrative Meeting and shall be reviewed by the University Endowment Fund Management Committee Meeting before taking force upon approval by the President. The same procedure shall apply when these Regulations are amended.
